INSTRUCTIONS FOR COUNTY FACULTY, STAFF, OR APPOINTED VOLUNTEER COORDINATOR:

- 1. Upon completion of your county qualifying show(s) determine who will represent your county at the state show in each class based on the members' placings & Danish ratings.
 - a. Counties may send UP TO (3) Senior and (3) Junior members in each class provided they have met the Danish qualifications for that class, and have shown in the required Showmanship & Grooming Class.
 - b. (3) per class represents the maximum counties are not required to fill this quota.
 - c. The State Horse Show Committee reserves the right to combine or split classes as necessary based on registration numbers.
- 2. Using the directions provided with the NJ State 4-H Horse Registration Database file, enter show results into the database to generate the Entry Form for each equine/member combination who qualified.
 - a. For the database to auto fill correctly, the name of the horse/pony/VSE in the database MUST correspond to the name on the project registration form and Coggins test.
 - b. Only those riders/equine submitted on official entry forms will be allowed to exhibit; incomplete or handwritten forms will not be accepted.
 - c. If a member/equine is only an alternate for the class an entry form for that member/equine must still submit their entry form, however, no fees will be due for that member/equine combination.

- **3.** Schedule a County SHS Informational meeting for your qualified members, and compile Participant Packets for each member that includes the following information/pages:
 - Their individual entry form with their information and designated classes for them to sign (printed from the database).
 - The Participant pages provided in this file (formatted to be printed double sided): Participant Information, State Horse Show Class Schedule, Office & Stabling Hours, Participant Responsibilities, Requirements and General Rules, Directions to the Gloucester County DREAM Park, NJ 4-H Horse Program Ethics Policy/4-H Code of Conduct, Stabling Reservation Form, Camper Reservation Form, State Horse Show Sponsor Form, NJ State 4-H Event Permission Form for Youth, and 4-H Release/Agreement Form for Adults.
- **4.** Provide the compiled packet to each qualified member and their parent(s) at your County SHS informational meeting.
 - a. It is the responsibility of the competitor and his/her parent/guardian to review the entry form for accuracy, sign the form(s), and return them to their county staff (or volunteer show coordinator) by the stipulated time.
 - b. Any animal under 15 hands and 7 years of age must have a copy of their pony measurement card attached to their entry form.
 - c. Dressage entries must have a copy of their qualifying test attached to their entry form.
 - d. County 4-H Staff are responsible to collect the completed and signed forms and payment.
- **5.** Email your updated database with your county show entries by **JULY 15** to Patty Burns via e-mail to pattyburns@comcast.net.
- **6.** The ORIGINAL HARD COPIES of each signed entry, 4-H Event Permission form, and corresponding 4-H Horse Registration paperwork must be sent to: Brittany Rigg, RCE of Gloucester County, Shady Lane Complex, 254 County House Road, Clarksboro, NJ 08020.
 - a. A color copy of the picture of the project animal must be attached to each 4-H Horse Registration paper and lease/borrow form.
 - b. Do not send original Coggins or a copy of the health papers with your entries as these should be with the horse/pony/VSE when they are transported and must be presented by the 4-H'er when they register at the State show.
- 7. Any change in entries should be submitted to both Brittany Rigg and Patty Burns by August 5.
 - a. All changes must be done by the county coordinator and are final.
 - b. Changes received after August 1 will not appear in the show program.
 - c. Late changes will be accepted by email until August 16; after that day the changes MUST be done through the show office (day of show) using the Scratch/Add Form provided.
 - d. No refunds of entry or stabling fees will be made after entries close for any reason.
- **8.** All returned checks (county or personal) will be assessed a \$50 fee. 4-H'ers/counties will not be considered a "Member/County-In-Good-Standing" on a state level until all financial obligations are met.
- **9.** Stalls are reserved using the stall form. Any horse/pony/VSE not reserving a stall must pay the\$20 non-stabled horse manure removal fee.
 - a. Any requests for additional stalls (or an initial stall) upon arrival on the grounds must be requested through the Stabling Coordinator, and paid for in CASH at check-in.
 - b. Payment by check WILL NOT BE ACCEPTED at the show.

ADDITIONAL FORMS TO INCLUDE WITH YOUR HARD COPY ENTRIES:

COUNTY COORDINATOR FORM

Each county must determine a County Coordinator for each discipline at the State Show in which they have members registered.

- Each county coordinator will need to have a copy of each competitor's entry form for each of the disciplines they are listed.
- Coordinators may only refer to information which is on the original submitted entry forms.
- It is the responsibility of the county coordinator to make any necessary scratches and alternate substitutions during the state show using the provided form.
- The county coordinator should be able to recognize all contestants from their county.
- Your members must know who their county coordinators are!

4-H FACULTY/STAFF VERIFICATION FORM AND COUNTY FEE SHEET

This form is to be completed by the 4-H Faculty/Staff member in charge of your county horse program to verify that all county participants are "members in good standing" and have an up-to-date record book. The bottom section of the form is where the county fees are to be calculated after all of the entry forms have been returned to the county office. The total due should match the total of all of your entries combined. That amount should equal the check submitted with your participant entry forms.

This form is to be returned with your participant entry forms NO LATER than July 15.

MOUNTED DRILL TEAM EXHIBITION GUIDELINES AND TEAM ENTRY FORM

The Mounted Drill Team Exhibition Information & Entry Form should be sent to the coach of the county drill team. This form does not have to be signed by the county agent. The team coach should return the form to Brittany Rigg no later than July 15.

AT THE EVENT

NJ 4-H RELEASE/AGREEMENT FORM FOR ADULTS

All adults (including trainers) participating in the weekend and/or staying overnight must complete a 4-H Release/Agreement Form and turn it into the show office upon arrival.

- Each county must confirm that there will be adequate housing for youth staying at the Show and proper adult chaperones.
- Chaperones must be the member's parent OR an Approved Screened 4-H Volunteer.
- Questions regarding this policy should be directed to your county 4-H staff/faculty.

COUNTY JOB ASSIGNMENTS

It takes many volunteers to run the state show. The County Job Assignment sheet tells which county is responsible for what task each day of the show. It is the county's responsibility to make sure they have ample volunteers that will be at the show during the specified time to fulfill their county's job obligation. Mounted Drill Team Guidelines

- The event will be held on Friday during the state show at the conclusion of the opening ceremonies at approximately 7:00 PM. Time may be subject to change.
- Each county may enter one team. There is no entry fee.
- Entries are due July 15. Return completed entry & permission forms to: Brittany Rigg, RCE of Gloucester County, Shady Lane Complex, 254 County House Road, Clarksboro, NJ 08020
- This is an exhibition only drills will not be judged, and all riders will receive a participation award.
- A drill may be no longer than 10 minutes (included in the ten minutes is set-up of equipment, introductions of riders and the actual drill). At the conclusion of 10 minutes, the music will be stopped and the team excused from the ring. **This will be enforced.**
- If the drill requires music, the music must be on <u>one</u> flash drive, CD, or mobile phone ready to play. If the music has been re-recorded from other tapes/cd's we cannot guarantee the volume in which the music will come across the PA based on the way the tape was re-recorded.
- If the drill requires narration, the script to be read must be TYPED with the lines double spaced.
- All music and scripts must be delivered to the Show Announcer prior to 5:00 PM on Friday.
- It is the responsibility of the county to retrieve their music and script. Any tapes left will not be returned after the show.
- 4-H'ers who have not qualified for the State Show may ride in the exhibition, however, they
 must be registered members of a 4-H Horse Club and be in grades 4 through 13 as of previous
 September. Such riders will need to fill out a 4-H Event Permission Form and return it with the
 team entry form.
- Horses that participate in the exhibition do not need to be registered project animals, however
 they must meet all health criteria. Proof of a current negative Coggins Test within 24 months
 and current shots must be brought to the show office upon arrival on the grounds.
- Stalls will be available at a cost of \$65 prior to July 15 and \$70 after that date. All non-stabled horses must pay the \$20 per horse manure removal fee charged by the Gloucester County DREAM Park.

2024 NJ State 4-H Championship Horse Show Participant Responsibilities, Requirements and General Rules

The following responsibilities, requirements and general rules are your responsibility to read with a parent/guardian and trainers before signing and returning the state show paperwork. This information should also be reviewed again prior to attending the event.

Participant and Parent/Guardian Responsibilities

It is the responsibility of the contestant and his/her parent/guardian to:

- Read all of the material contained in this packet.
- Complete and sign all necessary forms and return to your designated county show coordinator.
- If applicable, return a check for the appropriate amount with your entry form. Checks should be made payable to the designated county or state account. Entry fees are not refundable for any reason after the closing date. All returned checks will be assessed a \$50 fee. 4-H'ers will not be considered a "member-in-good-standing" on a state level until all financial obligations are met.
- Read the NJ State 4-H Horse Show Rule Book (2024 Edition). This show will be held in accordance with the Rules & Guidelines as set forth in this book. If you do not have a copy, it is available on the 4-H website at (https://nj4h.rutgers.edu/horses/horseshow).
- Demonstrate good sportsmanship (this includes participants, parents, relatives, friends, trainers/coaches, leaders and spectators) at all times. Offensive language and actions will not be tolerated. Violators may cause forfeiture of all awards to connected parties.
- Contestants are to register in person at the show office upon arrival on the show grounds. In order to receive their show number, each contestant must personally present to the show secretary the following:
 - An original copy of a valid Coggins Certificate (horse/pony/VSE name MUST match entry form). Please note, electronic Coggins Certificates must be printed to be valid.
 - Proof of up-to-date vaccinations for each equine entered in the show.
- 4-H'ers who arrive at the show with expired or invalid vaccinations/Coggins test will not be allowed to compete and must leave the show grounds. There will be no exceptions!

Entry Form

When your county holds their pre -show meeting, do the following:

- Review all general information (spelling of rider and horse/pony/VSE name, address, etc.) and classes that you have qualified for as a contestant or alternate.
 - The name of the equine on the entry form MUST correspond to the name on the Project Registration Form and Coggins Test.
 - Each horse/pony/VSE should have its' own entry form.
 - Any corrections must be noted on your entry form and given to your county's show coordinator so a new entry form can be printed.
- Both 4-H'er and Parent/Guardian sign the front of the entry form and return the original copy by the stipulated county due date.
- Complete and sign the "4-H Event Permission Form" and include it with your entry form.

Stall Reservations

- Stabling is limited to the number of stalls available on a first-come basis.
- Stalls must be reserved using the Stabling Form.
- Stabling questions should be directed to the show's stabling manager, Tammy Suydam, by emailing tsuydam@co.gloucester.nj.us or calling 856-224-8040 x3 (M-F, 8 AM 4 PM).
- Stall fees are non-refundable after July 15.
- All stall fees or shavings monies collected at the show must be paid for in CASH ONLY.
- There is no guarantee that county contestants will be stabled together. A reasonable effort will be made to do so whenever possible.

Overview of Event Rules (this is NOT a complete list – review the SHS Rulebook for full details)

- Dogs or Pets this includes in vehicles, campers, motor homes or trailers must be leashed, and are NOT permitted in the stabling or arena areas.
- Each non-stabled equine will be charged a manure removal fee of \$20.00.
- If a contestant decides to scratch a class, the county coordinator may substitute an alternate. However, the contestant will be scratched from the remainder of the three-day show and cannot decide to participate in a subsequent class. (i.e. If a member/equine combination is scratched Friday, that combination cannot compete Saturday or Sunday.) (SHSRB)
- Only your County Coordinator may make alternate changes the day of the show. Once the alternate substitution is made, the change remains final. (SHSRB)
- If a contestant is unable to participate in a particular class because of a problem, (i.e. heat stress, thrown shoe, etc.) certifiable by the farrier, veterinarian, show steward, judge or medical technician, then an alternate may be substituted by the county coordinator for that class only. The contestant will be permitted to participate in his/her remaining classes pending certification by said farrier, veterinarian, show steward, judge or medical technician. (SHSRB)
- As per State 4-H Department Policy, all participants in the show will be required to complete and attach to the entry form and a "4-H Event Permission Form".
- All volunteer leaders/coaches and parents acting as chaperons who are staying overnight on the show grounds must complete the "NJ 4-H Adult Release/Agreement Form".
 - This form is to be turned in to the show office during the event.
 - All counties with 4-H'ers staying overnight must have a minimum of two responsible adults staying with the participants.
- No outside equine (unless being used in a drill team exhibition) may be brought onto the show grounds for any purpose.
- Any vehicle (including horse trailers) parked in a designated "camper hook-up" space will be charged for a space whether the unit is hooked to the electric and water or not.
 - A camper permit must be reserved and paid for in advance of the show.
 - The permit is to be displayed in the door or window closest to the door of the unit.

Participants & Animals

The NJ 4-H State Horse Show Committee under New Jersey 4-H/ Rutgers University reserves the right to require immediate removal at owner's expense of any animal deemed by a licensed veterinarian to have or carry an infectious disease. Every effort to cooperate in aiding in removal of such animals will be taken. This rule is written to insure the maximum level of protection for all animals from infectious and contagious diseases. This may require the cleaning and disinfecting of any trucks and vans that have been associated with the movement of animals that have been deemed to be diseased, contagious or infectious.

Vehicles & Parking Rules

- All vehicles, trailers, vans, and RV's must be parked in designated areas.
- In camper areas, all vehicles must be parked in designated areas.
- No livestock trailers may be parked in camper areas unless used only for living purposes.
- No animals in camper areas. INCLUDING DOGS!!!!
- Fees must be paid for all campers parked in the camper area, even if they are self- contained.
- Fire Marshals require that no vehicle may be parked within (75) feet of any building, pavilion, or tent, or in roadways surrounding such, in order for emergency vehicles to have access at all times.
- No vehicles are permitted on the roadway to the ponds.
- Roller skates, skateboards and rollerblades are not permitted.
- Bicycles, mopeds, ATV's scooters and golf carts may not be operated around the show office, pavilion, vendor area, stall aisles or paddock area except by disabled persons, or employees or show officials.
- All minors under (18) years of age are not permitted on any type of wheeled vehicle whether motorized or non-motorized.
- No unlicensed person may operate a motor vehicle anywhere on the grounds.
- Aids for the disabled (youth included) are allowed.

Health & Safety Rules

- Horse Show Management will remove dangerous, disruptive or unlawful persons from the property.
- DOGS ARE NOT PERMITTED IN THE STABLING OR ARENA AREAS. DOGS LEFT IN CARS OR VEHICLES WILL BE REPORTED TO LAW ENFORCEMENT.
- No smoking in offices, stable pavilions, spectator pavilion, equine building, tented areas or indoor arena
- Swimming by humans and/or equine/livestock in ponds is prohibited.
- Hypodermic syringes and needles are to be disposed of in the approved medical waste containers provided.
- In accordance to state regulations, no open fires are ever permitted on any part of the Gloucester County DREAM Park property. Barbeque grills may be used in the camper area only. THIS RULE IS STRICTLY ENFORCED.
- Tents or camping in tents is not permitted.

Facility Rules

- Only manure and bedding is to be placed in manure bins.
- Recycling bins must be used for cans, glass and plastic bottles.
- All sales ads/advertisements must be posted on the designated notice board in the pavilion only.
 - Bills are not to be posted on fence rails or posts, buildings, stall panels, show office, trees, etc.
 - MANAGEMENT shall take all steps that are reasonably necessary to enforce this rule.
 - Persons posting such ads/notices are responsible for the removal of all sales ads/advertisements at the completion of the show/event.
- Trash must be placed in proper receptacles. If excessive trash is found on the grounds at the end of the show/event, the removal will be billed to MANAGEMENT.
- Alcoholic beverages are not permitted.
- Horses/livestock are not permitted on the grassy area north of the outside arenas or near the outside spectator stands. This area is reserved for spectators only.

NJ 4-H Horse Program Ethics Policy

- 1. All 4-H'ers and adults including trainers, parents and leaders are expected to be polite, sportsmanlike and properly attired. Any act of discourtesy, direct criticism, interference, disrespect, disobedience and abusive or threatening conduct to the judges, show officials, committee members or any other competitors, or failure to follow the rules shall cause the 4-H'er to forfeit participation and dismiss them from the grounds.
- 2. The NJ State 4-H Horse Show Committee and the NJ 4-H Department Liaison will decide any infractions of ethics or the 4-H Code of Conduct.
- 3. The showing of unethically fitted/groomed horse/pony/VSE is prohibited. Unethical fitting will be deemed to consist of any method of altering the natural appearance or conformation of any part of the animal's body. Animals showing signs of having been operated upon or tampered with for the purpose of concealing faults in conformation and appearance or with intent to deceive relative to the animal's soundness will be disqualified. This includes:
 - The covering of white skin, hair or spots anywhere on the equine including, but not limited to the face, withers, girth, tail head area or legs is **NOT** allowed.
 - Steroids, artificial filling internally or surgical procedures are **NOT** allowed.
 - Excessive shoeing methods used to change an equine's normal gait is NOT be allowed.
 - Use of coat paints, colored show foam, graphite, colored powders, hair dyes or color rinses
 used to enhance coat color, cover sun bleached hair, or white spots is NOT allowed
 (whitening and color shampoos are considered to be cleaning agents, not a dye or color
 rinse, and ARE allowable).
 - Fly spray and non-colored coat polishes/conditioners ARE allowed to be used.
 - Baby oil, Vaseline, and other similar types of highlighters MAY be used on the face and other
 appropriate areas.
 - Clear or dark hoof polish/dressing **IS** allowed.
 - Baby powder, talc or chalk IS allowed to be used on the legs.
 - Reasonable corrective/therapeutic shoeing IS allowed.
- 4. Every exhibitor, in consideration of his/her entry being accepted, agrees to submit any animal so entered by him/her to inspection and agrees to have such animal submitted to any tests as may be designated and requested by the Show committee and agrees that the conclusions reached by the committee as to whether such animal is unethically fitted/groomed shall be final, without recourse against the committee and the show.
- **5.** No one may conspire, contribute to or cooperate with others to violate this code, either by their action or inaction.
- **6.** Exhibitors, owners, and parents are absolutely responsible for an animal's condition whether or not they did something in violation themselves or knew of treatment that violates the code.
- **7.** Exhibitors submitting a show entry consent to disciplinary action for violation of the 4-H Code of Conduct and Ethics Policy.
- **8.** By submitting a show entry, exhibitors verify that they have read and understand the 4-H Code of Conduct, show Ethics Policy, and show rules and regulations, as well as the consequences and penalties for violations. Exhibitors understand that evidence of violation of any state law will be released to the appropriate law enforcement authorities.
- **9.** Exhibitors and parents/guardians signing the show entry form and the 4-H Event Permission Form have verified that they have read, understand and agree to abide by the rules above.
